## Public policy

Ab1569: renewal legislation [forced outpatient tx] rereferred to committee8/6/12 to appropriations. Anticipated cost of \$150,000 or more. Need to know more about status of bill -- CAMHPRA opposed to using mhsa funding for it. After appropriations, then what? Camhpra has long been opposed to implementation of laura's law draft letter, legislative committee will coordinate w drc and cares coalition to develop veto it if it c omes before gov, but to support 2134. Oppose reauthorization bill Hernandez/

We've take position of opposition to 1569, reason being we support 2134. Make supportive arguments. Jim r to contact cares tomorrow. Legislative committee will coordinate with other organizations. 2134 better reflects pest practices and client-centered services.

2134: just discussed.

Ab1907: due process requiring inmates under realignment transferred to county jails to have medication due process. Order lasts for a whole year. Advocates listed, defined as counsel. This is not lps; but criminal justice law. Problematic. s/b public defender rather than patients' rights advocate. Similar to kahea hearing. Probably small number of state prisoners will have these hearings. Suggest amending legislation to exclude advocates as counsel. Chck it out; rereferred to appropriations, hearing 8/6. Who will pay cost of hearings? Realignment fund? Figure out where it is, then propose removing pra

Kg. remanded to marin county court for implementation procedures. 8/20 next negotiation meeting. Counties are expected to implement something on interim basis. Case was not appealed; is final. Wish opr could coordinate between different counties, get help implementing as should be. Camhpra should ask opr to take the lead. Coordinat w/mort and drc. Thatis where we should emphasize our pressure. Support counties in interim. Support mort and dan b. for implementation procedures. In some counties, san diego, santa clara, santa clara there were procedures for riese-like hearings for temporary consecutives. Footnote in case. Dan and mort write memo to all advocates for interim. Advocates send to county counsel and court urging use of LA [most robust] procedures. Jim to contact dan and mort. Jim m to contact state office.
