PAMILA LEW: LA: ONE MENTAL HEALTH ATTORNEY LEFT. HIRED NEW ATTORNEY, BRIDGET, AND ONE OTHER ADVOCATE, ANN. ANN REPRESENTING MANY MINORS IN METRO. SACRAMENTO: AGNES AND ANN COLLER. SHERRY. OAKLAND: DAN BRZOVIC AND MIKE STORTZ. AND NEW PERSON FOR KIDS ADVOCACY: MAGGIE ROBERTS. SAN DIEGO OFFICE [COVERING SAN DIEGO, IMPERIAL, AND ?]: OPENING NEW OFFICE IN APRIL, STAFFED BY MARGARET JACOBSEN, WILL BE HIRING ANOTHER MENTAL HEALTH ATTORNEY AND SOMEONE WORKING RE DEVELOPMENTAL DISABILITIES. A LOT OF WORK IS STATE-HOSPITAL DRIVEN, ALTHOUGH A LOT OF WORK THERE IS FORENSIC. ONE NGRI CASE, AT NSH FOR 19 YEARS FOR JUST THROWING ASHTRAY AT BROTHER; NO INCIDENTS IN HOSPITAL. RECENT ARGUMENT BEFORE STATE COURT OF APPEALS, WAITING FOR DECISION. HARD TO GET FORENSICS PATIENTS OUT; SUGGEST LOOKING AT CONDITIONS [RIGHTS VIOLATIONS] IN HOSPITALS. END OF 4-YEAR PLAN, FOCUS GROUPS SCHEDULED, ONE AT CRESTWOOD MANOR VALLEJO AND NAPA STATE HOSPITAL [LPS ONLY]. ALSO HARBOR HILLS [NEW NAME?] AND DAVIS GUEST HOME IN MODESTO.

IN VENTURA COUNTY, IN CONJUNCTION IN DAY TX PROGRAM FOR B&C RESIDENTS, WILL BE A FOCUS GROUP. SCHEDULE WILL BE ON WEBSITE.

CAMHPRA BOARD MEMBERS INVITED TO FOCUS GROUPS TO GIVE ADDITIONAL INPUT. TIMEFRAME: WITHIN NEXT COUPLE OF MONTHS AFTER INTERNAL TRAINING. KIDS KEPT IN LONG TERM FACILITIES TOO LONG BEFORE PLACEMENT. PROBLEMS OF KIDS TREATED ON ADULT UNIT [SANTA CLARA]. SAN DIEGO: REGIONAL CENTER ISSUES. KERN: INTERVIEW EVERY CLIENT SCHEDULED FOR ECT. USUALLY ELDERLY DEPRESSED PEOPLE NOT RESPONDING TO MEDICATION. PROSPECTS CLUELESS TO OPTIONS. NOT CLEAR WHY PEOPLE ARE GIVING CONSENT. SAN LUIS OBISPO: MD DOING OUTPATIENT SHOCK AFTER DESIGNATED FACILITY CLOSED. MONTEREY: NO REVIEW COMMITTEE FOR 20 YEARS, NOW LICENSING INSISTS THAT ADVOCATE BE ON REVIEW COMMITTEE. SAN DIEGO: NEED ADEQUATE SERVICES AND SUPPORTS TO BRING CLIENTS OUT OF IMD'S [OHMSTEAD].

ARTICLE DISTRIBUTED RE PSYCHIATRIC MINORS IN JUVENILE JUSTICE SX.

PAUL GEROWITZ: CLARIFICATION ON REGIONAL CENTER ISSUES. ADELE: COMPILED LIST OF NAMES AND HOW LONG THERE. REGIONAL CENTER CLIENTS THERE ON NO

STATUS. WRITS: FORCE REGIONAL CENTER TO MAKE PLACEMENT. CAROLYN: POOR RESPONSE TIME FROM OFFICE OF CLIENTS' RIGHTS.

PAUL GEROWITZ' 1424 MEMO [INTERNAL TO PAI]. NO FAMILY RIGHT TO BE PRESENT AT HEARING. SOLICITING FEEDBACK. WILL ALWAYS STAY IN THIS FORMAT. [MEMO TO CATHY BLAKEMORE]. NO ABSOLUTE DISCRETION OF HEARING OFFICER TO ALLOW FAMILY INTO HEARING OVER OBJECTION OF PATIENT. DID NOT PREVIOUSLY HAVE THAT DISCRETION BECAUSE OF 5328. NOW 5328 EVEN STRONGER DUE TO 1424 REFERENCES TO 5328. "SHALL CONSIDER" -- POLICY ISSUE: IF CAMHPA MADE PUBLIC STATEMENT THAT FAMILY NOW HAVE RIGHT TO COME INTO HEARINGS, THEN EVERY ADVOCATE IN A VERY DIFFICULT POSITION. LOYALTY IS TO CLIENT, NOT TO CAMPRA. DMH POSITION IS NEUTRAL. 5328: NO ONE IN HEARING OVER OBJECTION OF PATIENT RATHER THAN THOSE LISTED TO BE THERE. NEW LAW: 5328 PREVAILS. LEGISLATIVE INTENT: ARGUE PLAIN MEANING OF WORDS IN BILL. AMBIGUOUS? INTERPRETED IN FAVOR OF PARTY PROTECTED BY LAW = PATIENT. ISSUE FOR WRIT OF MANDATE THAT, AS IN SAN DIEGO COUNTY, COURT NOT RELEASE DATE AND TIME OF HEARING. WHAT TO DO WHEN FAMILY MEMBER IS ALREADY AWARE AND A POTENTIAL WITNESS: IF NOT SUCCESSFUL IN KEEPING OUT OF HEARING, FAMILY MEMBER WILL HAVE TO RESPOND TO QUESTIONS AND THEN LEAVE. HOW ARGUE NO PRESENCE WHATSOEVER IN DUE PROCESS HEARING? TO JUST PROVIDE INFORMATION. BURDEN OF PROOF IS ON HOSPITAL, HOSPITAL MUST GET INFORMATION AND PRESENT IT. REVISE CAMHPRA LETTER, "SUPERCEDES"? FAMILY MEMBER IS STILL PREVENTED FROM HEARING CONFIDENTIAL MATERIAL. SITUATION WHERE FAMILY KNOWS THEY ARE THERE, NOT HOSPITAL CONTACT W/O PERMISSION. WHAT TO DO WITH CAMHPRA LETTER: JIM AND DIANE TO HELP HANK REVISE CAMHPRA LETTER.

PAUL SUGGEST INCLUDING OTHER SOURCES AS ADDENDA [FEEDBACK] AND CIRCULATE AS ATTACHMENT WHAT WAS HEARD FROM OTHERS. POINT: LEGALLY AN OPEN QUESTION. TEST FOR LEGISLATIVE INTENT IS INTENT OF LEGISLATURE, NOT AUTHOR. CAMHPRA PUT OUT REVISION OF PRIOR INTERPRETATION, CIRCULATE TO EVERYBODY. HOW MONITOR CHANGES THAT DO OCCUR? ARE PRACTICES IN COUNTIES CHANGING AS A RESULT OF THIS BILL? COALITIONS? LEGAL SUBCOMMITTEE?

PAUL: THOMSON'S 1421 IS IN SENATE. MAY PRODUCE ANOTHER BILL. OPR: NOT MUCH TO REPORT: MET W/SENATE STAFF RE BUDGET CUT. TOLD WOULD GET HELP WITH THAT. RE LACK OF INDEPENDENCE [OVERSIGHT] PAUL FEELS WILL NOT CHANGE. NO WAY TO CHANGE THAT. ATTEMPT AT LEGISLATIVE CHANGE WOULD NOT WORK AND WOULD ONLY BRING MORE WRATH FROM DEPARTMENT. TRULY INDEPENDENT: WHO WOULD OPR ANSWER TO? OFFICE OF CONSUMER AFFAIRS? NOW, ADVOCACY IN THE ABSURD. HOW ADDRESS? GET LEGISLATIVE BUDGET STAFF TO CLOSELY QUESTION DMH RE PRACTICES. WOULD NEED TO FOCUS ON THE ISSUE. COULD BACKFIRE. NEEDED PEOPLE MAY NOT BE WILLING TO HELP US ON THIS ISSUE. DAY: POLITICAL PRESSURE? DELAYS IN APPROVAL. NOT LIKELY TO COME AROUND THROUGH PUBLIC OPINION. PERHAPS INTERACTION BETWEEN LEADERSHIP OF HOLDER OF OPR CONTRACT AND DMH. EASIER TO SAY THAN DO. ALL ISSUES FOR DAY'S COMMITTEE. POSSIBLY CARRY LEGISLATION? PAUL MAY KNOW POSSIBLE AUTHOR. INTRODUCE BILL AS POINT OF DISCUSSION. LOOK TO OUTSIDE GROUPS SUCH AS CIVIL RIGHTS OR ACLU - AT LEAST ONE ENTITY NOT IDENTIFIED AS PATIENTS' RIGHTS GROUP.

PAI RATHER SCATTERED, HARD TO DO SX CHANGE. NEED TO BE REALISTIC IN TAKING THINGS ON WHERE CAN MAKE A DIFFERENCE.
