RESIDENTS SHOULD BE ABLE TO SEE INDEPENDENT PSYCHIATRIST, NOT HOME ASSIGNED. NUTRITION STANDARDS: WORSE FOR B&C THAN FOR JAIL, AND STILL NOT ENFORCED. POSTING OF REPORTS -- NOT DONE. FINES NOT ENFORCED. LANGUAGE/LITERACY/CULTURAL COMPETENCE: SUGGEST HIGH SCHOOL DIPLOMA OR GED; CAN'T COMMUNICATE IN CASE OF EMERGENCY.
