DAY AND HANK DESIGNATED BY CAMHPRA BOARD AS POINT PEOPLE FOR CARES, MAY COMMIT WITH APPROVAL OF EXECUTIVE COMMITTEE. ONE LARGE MEETING IN SACRAMENTO WITH MANY FROM NETWORK, CASRA, PAI. STRATEGY SESSION THREE WEEKS AGO TALKING ABOUT BILLS. COMMITTED TO 3 CARES BILLS, AB 1421 [OPPOSED] SB 931 BURTON [SUPPORT], SB 891 [SUPPORT]. NEED TO WRITE CAMHPRA ASSOCIATION LETTERS ON THESE BILLS.

# 1. AB 1421 [THOMSON] [OPPOSE]

2 PAI ANALYSES AND PROPOSED AMENDMENTS

THOMSEN CITES RAND STUDY IN ERROR TO SUPPORT THIS BILL. [MISREPRESENT, MISQUOTE] NO AMENDMENT WOULD MAKE PALATABLE, BUT STEINBERG [CHAIR OF JUDICIARY] HAS SUBMITTED POSSIBLE AMENDMENTS SUGGESTING CRITERIA FOR INVOL CRITERIA BE LPS CRITERIA; THAT WHOLE PERIOD BE 14 DAYS RATHER THAN 30; AND TECHNICAL AMENDMENTS TO MAKE READ BETTER. STEINBERG MAY SUGGEST THAT CARES SIT DOWN WITH THOMSEN TO WORK OUT SOMETHING PALATABLE.

SUSPENSE TIL NEXT FEBRUARY, THEN SUSPENSE.

ABUSE: HOMOSEXUAL AND HEEROSEXUAL RAPE; INADEQUATE BED CLOTHING AND FOOD. TRANSPORTATION PROBLEMS, CULTURAL COMPETENCY ISSUES. NEED FOR RESPITE. GOAL: IDENTIFY CONCERNS AND PROCEED TO MAKE CHANGES PHASE IJ. NOW, PHASE II. PUT DATA TOGETHER AND GO TO WHOEVER WILL HELP. TRY TO BE NON-THREATENING, THAT'S WHY IT HAS TAKEN SO
